Treasurer's Update

USSYAA operates on a cash basis and for the period January 1, 2024 through August 31, 2024, year-to-date ("YTD") expenses were \$22,084.41 and consist of scholarships, our annual dinner, regional events, communications costs, and various operating and administrative costs.

Contributions from members are a critical part of the Association's financial picture. Through August 31, 2024, donors have earmarked \$3,010.00 toward our scholarship programs.

Assets of the USSYAA are held at Fidelity Investments and consist of mutual funds, exchange-traded funds, and common stocks. The USSYAA's Finance Committee manages its investments with the goals of maximizing portfolio assets and supporting the organization's Mission Statement. Tax returns are available at ussyaa.org.

Each year, we award the Rosalie Wynn Hearst Distinguished Service Award, named for our beloved "Mom" Hearst. Scholarship Application Period Open

One of the signal goals of the USSYAA is to provide scholarships to help Hearst Program delegates pursue post-graduate academic programs to help continue to provide service to the broader community. The Rosalie Wynn and George Hearst Scholarship (\$5000) and Chandini M. Bachman Scholarship (\$2500) are available to all eligible program participants to fund graduate studies at U.S. schools or abroad. Past recipients and applicants have pursued studies in fields as diverse as medicine, community health, government affairs, international relations, art education, divinity school, many kinds of law, journalism, economics, cybersecurity, public policy, and many more. Every applicant and every scholarship winner has shown the continued creativity and commitment to service USSYAA champions.
